# 7. Your rights as a data subject

The GDPR provides the following rights for individuals:

**Right of access**: You are entitled to obtain both access to and a copy of the personal data processed, on request

**Right to rectification**: You are entitled to obtain a rectification of your personal data if they prove to be inaccurate or incomplete

**Right to erasure**: You are entitled to obtain the erasure of your data when there is no longer a valid reason for processing them

**Right to limitation of processing**: You are entitled to obtain a limitation of processing of your data that is inaccurate or no longer necessary

**Right to object**: You are entitled to obtain a cessation of the processing of your data where there are no legitimate and compelling reasons for processing them

**Right to data portability:** You are entitled to obtain the transfer of your data to a third party in an accessible format

**Rights related to automated processing and profiling**: You are entitled to obtain that data are not processed fully automatically without human intervention

If we need to process any of your personal data in a manner other than that previously identified, we will contact you to provide you with information about this and to seek your consent if necessary.
